

1. **Who can enter?** All Players' Club members who are 18 years of age or older with a Players' Club Card.
2. **When?** Saturdays in January 2019 (5,12,19,26) from 5pm to 10pm (each a "Promotional Day").
3. **Where?** Winner's names will be announced over the PA system and the winner must report to the Players' Club within two (2) minutes.
4. **How:** Saturdays in January 2019 from 5pm –10pm, Players' Club members who are actively playing with their Players' Club card properly inserted in any slot machine from 5pm to 10pm on a Promotional Day will have a chance to be randomly selected to win. One (1) winner per hour will be randomly selected and their name will be announced over the PA system. Announcements may not be heard in all areas of the facility. The winners have two (2) minutes to report to the Players' Club. A member who is unable to report to the Players' Club within two (2) minutes may, within the two (2) minutes, contact a member of the gaming floor staff who will make radio contact with the Players' Club to make the winner's presence known. After the two (2) minutes, if the winner has not reported to the Players' Club or contacted a member of the gaming floor staff, and presented valid photo ID, the selection becomes invalid and the name of another random winner will be selected. The process is repeated until a valid winner is eligible to participate.

There will be twenty-four (24) winners for the Promotional Period. Players' Club members may win more than once on a Promotional Day and may win more than once over the Promotional Period. Winners must be present to win.
